Inhale Manhood PRIVACY NOTICE — IMPORTANT — PLEASE READ

Last updated on August 17, 2015.

This Online Privacy Policy (the "Privacy Policy") applies to Inhale Manhood online interface (i.e. website, mobile applications, electronic services, and social networking sites (collectively, the "Site") owned and operated by Inhale Manhood, Inc. ("Company"), and any Company affiliate or subsidiary online interface that links to this Privacy Policy. The Privacy Policy discloses the information gathering and dissemination practices to help you understand how we treat the information we collect and how such information is used and shared.

Agreement to this Privacy Policy: By using this Site you consent to this Online Privacy policy, including your consent to our use and disclosure of information about you in the manner described herein.

Browsing Our Website The Site does not collect personally identifiable information from your computer when you browse the Site and request pages from our servers. This means that, unless you voluntarily and knowingly provide us with personally identifiable information, we will not know your name, your email address, or any other personally identifiable information. Company's servers automatically record non-personally identifiable information when you visit our website or use some of our products. When you request a page from the Website, our servers log the information provided in the HTTP request header including the IP number, the date and time of the request, the URL of your request, the language used, the browser type and any other information that is provided in the HTTP header. We collect the HTTP request header information in order to make the Website function correctly and provide you the functionality that you see on the Website. We also use this information to better understand how visitors use the Website and how we can better tune it, its contents and functionality to meet your needs.

Collecting and Using Information

Registration and Other Information Provided to Us

When you visit Inhale Manhood, you may be asked to disclose personally identifiable information. You may also choose to submit personally identifiable information to us when you send us an e-mail. You acknowledge and agree that we may use and store any such information about you in accordance with our Privacy Policy. We may also process and store your personally identifiable information on a server located outside of your jurisdiction. By providing your Personally Identifiable Information to us, you

consent to the transfer of your information across national boundaries. If you do not consent to such transfer as well as the processing and storage of your personally identifiable information outside your jurisdiction, you should not provide such information to us.

What information does the Site obtain?

User Provided Information:

When you register with us or use the Site, you provide us certain information voluntarily. This may include: (a) your name, mobile or residential phone number, zip code, e-mail address, postal address, date of birth, gender, answers to survey questions and other registration information; (b) transaction-related information, such as when you make purchases, respond to any offers, or download or use applications from us; (c) information you provide us when you contact us; (d) information you enter into our system when using the Site, such as contact information which is clearly labeled at the time you submit it; and (e) information you post on our Site to the extent we permit posting information.

Automatically Collected Information:

When you use the Site, we automatically collect certain information from you, such as Internet addresses, browser type, Internet Service Provider (ISP), referring and exit page, operating system, timestamps, clickstream data, the type of mobile device you use, your mobile device's unique device ID, the IP address of your mobile device, and your mobile operating system. We also track and analyze non-identifying and aggregate usage and volume statistical information from our visitors and customers. This information is logged and used for purposes such as to help diagnose technical problems and to administer our Site so that we can constantly improve it.

Cookies:

Cookies are small text files placed in your browser. Cookies transmit information such as session ID, user ID, and conversion data. This information helps website providers recognize a browser or mobile device and helps us gather information such as how many users have visited our site and which pages and advertisements have been seen and clicked on. We use first-party cookies and third-party cookies together to report ad impressions, other uses of ad services, and interactions with ad impressions related to your visit to our Site. We never collect sensitive personal information (such as information about your race, religion, sexual orientation or health) from cookies.

Third-Party Analytics

We may collect certain information via third-party analytics services, which may collect your non-sensitive user information. This may include: the information you provide us, your session ID, your user ID, and conversion data. This information provides us with tools to calculate the numbers and frequency of visitors on the Site and to understand how you and other users use the Site so to improve your experience.

How is the obtained information used and shared?

We use the information that we collect for purposes including to provide our services, contact you regarding new promotions, improve our Site, resolve disputes, troubleshoot problems and enforce our customer agreements. We also use this information—directly, indirectly, and in combination with data we exchange with other parties—to introduce you to informational, service and/or product offerings of Inhale Manhood and Company.

Emails & Newsletters:

When submitting any information on our website you expressly authorize Inhale Manhood and Company to use your personal information as explained in this privacy policy, and you consent to receiving commercial email from Inhale Manhood and Company. You can expect to receive offers regarding specific products and/or services, newsletters, sweepstakes announcements, promotions, and other similar offers. Should you wish to discontinue receiving these e-mailings simply unsubscribe using the link in the email you receive.

Advertising:

The Site may provide you with advertisements, including in-text link ads. Information we collect through cookies and other technologies that does not by itself identify you is used to assist us in delivering you relevant ads when you are on a webpage. We may work with third-party advertising networks and advertisers who help deliver these ads to you and who may collect information about your browsing activity over time and across different sites in order to make this advertising more relevant. We also use cookies to improve the performance of our advertising on other websites. Although you may not opt out of receiving online advertisements generally, you may control the collection of data on our Site used for targeted Inhale Manhood advertising during your visits to other websites. To opt-out of Inhale Manhood data collection for targeted advertising on other sites, see "Cookies" under the section "What

are my opt-out rights?"

Inhale Manhood advertises online (e.g., pages within our Sites and mobile apps through company managed social media presences, and on other sites and mobile apps not affiliated with Inhale Manhood) and offline (e.g. through call centers, and direct marketing). In order to understand how advertising performs, we may collect certain information on our Sites and other sites and mobile apps through our advertising service providers using cookies, IP addresses, and other technologies. The collected information may include the number of page visits, pages viewed on our Sites, search engine referrals, browsing activities over time and across other sites following your visit to one of our Sites or apps, and responses to advertisements and promotions on the Sites and on sites and apps where we advertise.

Inhale Manhood uses information described in this Privacy Policy to help advertise our products and services in a variety of ways. We use such information to:

Present tailored ads, to you including:

Banner ads and splash ads and other mobility applications

E-mail, postal mail, and telemarketing

On other sites and mobile apps not affiliated with Inhale Manhood;

Analyze the effectiveness of our ads; and

Determine whether you might be interested in new products or services

How we tailor ads:

Relationship based advertising

In order to help make our advertising informative and useful, we may use information about your relationship with us (such as types of services, transactional information or the state in which you reside) to help determine which advertisements or offers to present to you.

Online Behavioral Advertising

We or our advertising service providers may use certain information about your activities on our Sites, such as pages visited and search key words entered to help determine which of our advertisements or offers may be of interest to you. We limit access and collection of information for specific purposes by advertising service providers. We may use this online information for online and offline advertising, which we may feel will be a benefit to you.

Advertising on third party sites and mobile apps

Inhale Manhood may contract with advertising companies to advertise our products and services on sites and mobile apps not affiliated with us. We may use Aggregated and De-identified Data and information provided by you to these third party sites and mobile apps to select which of our advertisements or offers may appeal to you, display them to you and monitor your responses. Third Party sites and mobile apps are not subject to Inhale Manhood Privacy Notices. Please visit the individual sites and mobile apps for additional information on their data and privacy practices and opt out policies.

Online Behavioral Advertising on third party sites and mobile apps

Some of our tailored ads are online behavioral advertising, and may be served using data collected by third party providers. Ads served on our behalf by these companies do not contain unencrypted Personal Information and we limit the use of information by companies that serve our ads.

Other Data Sharing: In addition, we may share information that we collect:

With our vendors or service providers who help us operate our business;

In response to a subpoena or similar investigative demand, a court order, or a request for cooperation from a law enforcement or other government agency;

To establish or exercise our legal rights;

To defend against legal claims;

When we believe disclosure is necessary to investigate, prevent, or take action regarding illegal activity, suspected fraud or other wrongdoing; to protect and defend the rights, property or safety of our company, our employees, our web site users, or others; or,

To enforce our website agreements or policies

We may also transfer any data we collect in connection with a corporate change such as a merger, our acquisition by another company, or a partial or total sale of our assets (including as part of a bankruptcy proceeding).

What are my opt-out rights?

You may decline to provide personal information to us and/or refuse cookies in your browser, although

some of our features or services may not function properly as a result.

If you no longer wish to receive our promotional communications, you may opt-out of receiving them by following the instructions included in each communication or by emailing or calling us per the information contained on our contact page.

By providing information to Company you are consenting to the collection, use and disclosure of such personal information in the manner described in this privacy policy. We provide you the opportunity to withdraw your consent when such information is collected or at any later time by following the procedure described in this provision.

Data Retention Policy, Managing Your Information

We will retain User provided data for as long as you use the Site and for a reasonable time thereafter. We comply with HIPAA security requirements with respect to safeguarding and securing your Protected Health Information. Unfortunately, no data transmission over the Internet can be guaranteed to be

absolutely secure. As a result, while we strive to protect your Personally Identifiable Information and Protected Health Information, we cannot ensure or warrant the security of any information you transmit to us, and you do so at your own risk. If Company provides you with a user name and password to access portions of the Site, Company disclaims any responsibility for a breach of privacy as a result of your willingly or inadvertently disclosing your user name and password to others.
